$$P = \sum_{t=1}^T \frac{CF_t}{(1+R)^t} + \frac{F}{(1+R)^T} = (1)$$
 Where CF Denotes The Cash Flow At Time T, R Denotes The Yield To Maturity And P Denotes The Bond Price.
